#### **WORC 2025 Fall Hiring Event Recap**

The Workforce Opportunity Resource Center (WORC) hosted a successful Fall Hiring Event on October 2, 2025, drawing 218 job seekers including 125 CHA residents eager to take the next step in their careers. Support from leading employers like Northwestern Medicine, the Chicago Police Department, and Waste Management, participants explored career pathways in healthcare, public service, transportation, and more.

The event resulted in 10 attendees receiving job offers and 22 others being scheduled for interviews. Many left with a renewed sense of motivation and clear next steps. Feedback from 79 participants and 24 employer surveys reflected overwhelmingly positive responses, praising the event's strong organization, employer engagement, and welcoming atmosphere. WORC remains committed to empowering CHA residents with access to meaningful employment and training opportunities that build stronger, more resilient communities.
